How to Accept a Master's Research or PhD Offer Online

STEP 1: LOG INTO THE UKZN STUDENT IENABLER PORTAL

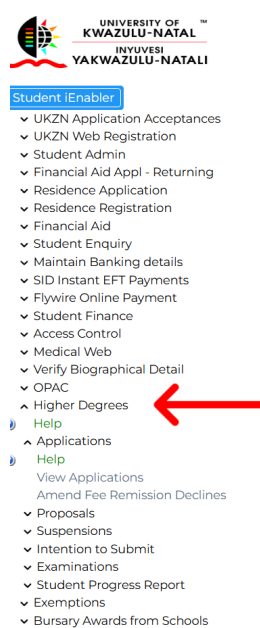

- Under 'Registered Users: Login Credentials':
 - » Select 'Student'
 - » Enter your Student Number
 - » Enter your 5-digit PIN
 - » Click 'Login'

If you do not know your PIN, select 'Forgot PIN' or 'Request a PIN'.

STEP 2: NAVIGATE TO HIGHER DEGREES



- Click on 'Higher Degrees' in the left-hand menu
- Select 'Applications'
- Click on 'View Applications'

STEP 3: VIEW AND SELECT YOUR APPLICATION

- Your applications will be listed
- Click on the student number next to the correct application


STEP 4: ACCEPT THE OFFER

- Tick 'Remission of Fees' (if applicable)

Fee remission are funds set aside by the University to assist students with their fees. This is currently for year 1 of your MSc and for years 1 to 3 of your PhD. If you wish to take advantage of this, please follow the steps below after accepting the offer:

Click on the Fee Remission (see screen below) and acknowledge the terms and conditions and ACCEPT - FEE REMISSION to generate an automated clearance (unless blocked by outstanding fees/international/ academic holds)

- Click 'Accept Offer'

- Acceptance of Offer Form ([Download](#)). If you were offered residence, also include the Residence Form ([Download](#))
- Proof of payment of the required deposit
- Certified copy of your ID or Passport
- Certified copy of your academic results or qualification certificate

Submissions must be sent to the College-specific contact details as provided by the University (refer below).

Important Notice

If you do not accept the offer within three (3) days, the offer will be automatically withdrawn. Due to the high volume of applications received by the University, the place will be offered to another applicant.

Tuition fees are payable in full prior to registration. Students are strongly advised to make payment at least two (2) weeks before registration in 2026.
